## **ZESBI** Background & Eligibility Overview

## **ZESBI Background**

The Zero-Emission School Bus and Infrastructure (ZESBI) project pairs zero-emission (ZE) school bus vehicle funding offered by the California Air Resources Board (CARB), with charging infrastructure funding offered by the California Energy Commission (CEC).

A total of \$500 million is appropriated by Senate Bill (SB) 114 for ZESBI for Fiscal Year 2023-24.

ZESBI Project Type	Awards
ZE School Bus	• \$375 million is allocated to support the replacement of old school buses with ZE school buses
Charging Infrastructure	• \$125 million is allocated to support complementary infrastructure and associated costs



## **Eligibility & Requirements**

#### **Eligible applicants\*:**

- California Public School Districts
- California Public Charter Schools
- California Joint Power Authorities (JPAs)
- California County Offices of Education (COEs)

#### Ineligible applicants:

- Private schools are not eligible applicants
- Charter schools classified as nonclassroom-based charter schools as of FY 2021-22 are not eligible.
- Third-party student transportation providers

\* Eligible applicants can contract with third-parties to operate the school buses.

\* All applicants must serve students within the K-12th grade level.



## **Application Prioritization**

#### **Applicant Prioritization:**

- **Tier 1** Applicants defined as a small or rural school district, or applicants whose total enrollment is comprised of at least 80% unduplicated pupils
- **Tier 2** Applicants that serve Disadvantaged Communities (DACs) and/or Low-Income Communities (LICs)
- Tier 3 Eligible applicants with an eligible school bus for replacement

\*Applicants within each tier will be ranked based on the timestamp of their complete Application Part A submission.



## **Eligibility & Requirements**

#### **Old School Bus Requirements:**

- Chassis must be a 2010 model year or older per the DMV Registration Form.
- Must be applicant owned. The school bus cannot have a lienholder listed on the DMV Registration Form.
- Must have a Gross Vehicle Weight Rating (GVWR) greater than 10,000 pounds.
- Must have a current California Highway Patrol Safety Certification (CHP 292 or equivalent) at time of Application Part A submission. A non-certified school bus will not be able to continue within the application process.
- If the school bus is diesel-fueled and greater than 14,000 pounds GVWR, it must be compliant with the California Truck and Bus Regulation in order to receive a full voucher amount.

#### Infrastructure Requirements:

- <u>1 ZESBI funded bus : 1 ZESBI funded charger</u>
  - o Charger requests may reflect up to the total number of ZE school buses requested.


### **Application Part A**

- ZESBI Application Part A will remain open until November 22, 2024, at 5:00 pm Pacific Time.
  - Application link can be found at <a href="www.californiahvip.org/zesbi">www.californiahvip.org/zesbi</a>.
- Applicant must submit the following:
  - A Letter of Intent signed by an authorized representative stating the applicant's intent to purchase ZE school bus(es).
  - A current copy of the DMV Registration for each old school bus included in Application Part A.
  - A current copy of the CHP Safety Certification (CHP 292) for each old school bus included in Application Part A. The old school buses must have a current, unexpired, (CHP 292 or equivalent) at time of application submittal.



## **ZESBI Applicant Portal**

- ZESBI Application Part B will open in Fall 2024 (for those who applied on or before Sept. 30).

- Applicant must submit the following school bus documents:
  - A copy of the current DMV registration with no lienholder listed
  - A photograph of the school bus manufacturer's ID tag(s)
  - A photograph of the school bus engine plate
  - A photograph of the engine block
  - A photograph of the side profile of the bus
  - California Truck and Bus Regulation Compliance Self-Certification (Only applicable to dieselfueled school bus(es), greater than 14,000 pounds GVWR, to be scrapped, not the entire fleet)
  - Clean Truck Check Certificate (Only applicants that own non-gasoline and non-electric vehicles (including school buses) with a gross vehicle weight rating (GVWR) more than 14,000 pounds)



\*The above items must be provided for each approved scrappage vehicle when applicable.

## **Application Part B**

- Applicants should be prepared to provide the following basic information about their planned infrastructure:
  - Project site address(es)
  - Estimated Quantity and Type of Chargers (e.g., two DCFCs, one L2 charger, one bidirectional DCFC).
  - Confirmation that you have reached out to and are working with your utility to verify they can provide the necessary power at your chosen project site(s). Examples of confirmation include the following documentation:
    - Notice that the project site is being assessed for energy load capacity, or notice that you are coordinating with your utility.

#### **School Bus Documentation Instructions:**

Please select the linked **Scrappage Vehicle Name** to access the Supporting Documents upload screen.

For each vehicle you will be required to upload:

- A photograph of the school bus manufacturer's ID tag(s): The photograph(s) must legibly depict the Vehicle Identification Number (VIN) and Gross Vehicle Weight Rating (GVWR). See example
- A photograph of the school bus engine plate: The photograph must legibly depict the engine serial number. See example
- A photograph of the engine block: See example
- A photograph of the side profile of the school bus: See example
- California Truck and Bus Regulation Compliance Self-Certification: Only applicable to diesel-fueled school bus(es), greater than 14,000 pounds GVWR, to be scrapped, not the entire fleet. You do not need to complete the certification if your application only proposed to scrap gasoline, natural gas, or propane fueled school buses, or school buses are under 14,001 pounds GVWR. A TRUCRS (Truck Regulation Upload, Compliance and Reporting System) self-certification is available in the ZESBI application portal. For more information, please see here. In cases where the old school bus is not compliant, a \$20,000 incentive deduction will be applied per non-compliant school bus.
- Clean Truck Check Certificate: Only applicants that own non-gasoline and non-electric vehicles (including school buses) with a gross vehicle weight rating (GVWR) more than 14,000 pounds are required to submit their Clean Truck Check Compliance Certificate which can be obtained through the <u>Clean Truck Check Reporting Database</u>.


Note: If you are proposing to scrap more than 10 school buses, you may need to select "View All" to see all of your buses.

#### **General Instructions:**

Upon uploading all Supporting Documents, select the linked **Application** number, or select the **Back** button on your device to return to the application screen. **Repeat for each bus until you have uploaded all the Supporting Documents for each old school bus you intend to scrap.** 

Once you have filled out all fields in each Application Part B tab, select "Submit Application". If you have not filled out one or more fields, you will receive instructions to complete those fields before you can successfully submit your application.

Once you successfully submit your application, you will receive an email to the primary email that you provided (in Application Part A), confirming receipt of your application submission.

Applicants will be able to view documents that were uploaded during Application Part A (e.g., DMV Registration and CHP 292). Applicants will not be able to edit the existing documents in the portal or the scrappage vehicle details on the left pane. No further action is needed for the existing scrappage vehicle details and documents that have been processed and approved by ZESBI Staff.

- 1. Select the linked **Document Number** under "**Supporting Documents**" to upload any documents which are "waiting for upload". If necessary, please click "**View All**" under Supporting Documents to see a full list of documents.
- 2. After you select the Document Number, the system will instruct you to "Add Files" to upload the document type you selected.
- After uploading your document, select the Scrappage Vehicle link or select the Back button on your device to return to the old school bus profile
  and upload any additional documents waiting for upload.
- 4. Select the Application Number or select the Back button again to get back to the application screen.

You may repeat these steps above until all documents for each eligible scrappage vehicle has been uploaded.

Diesel-fueled school bus(es), that are greater than 14,000 pounds GVWR, must be compliant with the California Truck and Bus Regulation in order to receive a full incentive amount. In cases where the old school bus is not compliant, a \$20,000 incentive deduction will be applied per non-compliant school bus.

To maintain compliance with the CA Truck and Bus Regulation, school buses must have a diesel particulate filter (DPF) installed or operate less than 1,000 miles per calendar year (low use). Please see here for more information.



# CARB CLEAN TRUCK CHECK OVERVIEW







### Clean Truck Check

#### Clean Truck Check: Overview

- Nearly all on road heavy-duty vehicles with a gross vehicle weight rating over 14,000 pounds operating in California must comply.
- This includes all diesel, hybrid, and alternative fuel vehicles.
- Zero-emission and gasoline heavy-duty vehicles are exempt.



## **Example Regulated Vehicles**

Don't let the name fool you—Clean Truck Check applies to more than just trucks. Regulated vehicles include:

- School buses
- Cargo vans
- Trucks
- Agricultural vehicles
- Transit Buses
- Tow trucks
- Personal vehicles















Clean Truck Check: How to Comply

- 1. Register & report vehicles in CTC-VIS
- 2. Pay the annual compliance fee per vehicle
- 3. Submit passing emissions compliance tests





## Reporting in CTC-VIS

- Vehicle owners are required to report via the Clean Truck Check,
   Vehicle Inspection System (CTC-VIS) at <a href="https://cleantruckcheck.arb.ca.gov/">https://cleantruckcheck.arb.ca.gov/</a>
  - Create an account in the CTC-VIS database
  - Enter fleet and vehicle info
  - Pay required annual compliance fees
- Vehicle compliance requirements can be checked on CTC-VIS
  - CTC-VIS will send out a monthly summary email notification for the fleet/vehicles' that have upcoming deadlines in the next 90 days



# Reporting in CTC-VIS

#### Welcome to the California Clean Truck Check, Vehicle Inspection System (CTC-VIS) Portal

The California Air Resources Board (CARB) is the primary state agency responsible for actions to protect public health from the harmful effects of air pollution.

The new CTC-VIS program is our newest of these approaches, with which we will realize substantial emissions reductions from the heavy-duty vehicle sector and reduce the risk of harmful criteria pollutant exposure to all individuals living in California.





# **Annual Compliance Fee**

- Pay the annual compliance fee for each vehicle via CTC-VIS
- Current annual fee will be adjusted with California Consumer Price Index (CCPI)
- Payments via credit card, debit card, or e-check
  - Paper checks will not be accepted
- Batch payment option available



# **Emissions Compliance Testing: Semi-Annual**

Applies to most vehicles

- 1st Deadline: DMV registration due date
- 2nd Deadline: 6 months from the DMV registration due date
- DMV exempt plated vehicles' compliance deadlines are based on the last number of the vehicle's vehicle identification number (VIN)
- Compliance tests can be submitted no sooner than 90 days prior to a deadline



# **Compliance Test Methods**

#### OBD vehicles

- ≥2013 MY diesel or diesel hybrid engines
- ≥2018 MY alternative fuel or hybrid alternative fuel engines

#### Non-OBD vehicles

- Opacity test
- Vehicle emissions control equipment
  - Visual and functional inspection
- Only visual inspection for alternative fuel vehicles







# **OBD Testing Devices**

- Only CARB-approved OBD test devices can be used for Clean Truck Check compliance tests
- CARB-approved OBD test devices are posted on the Clean Truck Check website

The California Air Resources Board (CARB) has issued Executive Orders (EO) for the following devices that meet the requirements for periodic On-Board Diagnostic (OBD) vehicle emissions testing starting in 2024 as specified in Title 13, California Code of Regulations (CCR), Section 2196.3(a)(1) and (2) of the Heavy-Duty Inspection and Maintenance (HD I/M) Regulation. Only CARB-certified OBD test devices can be used when performing periodic compliance tests on eligible vehicles for Clean Truck Check.

Please reach out directly to device vendors to purchase CARB-certified OBD test devices for your vehicles/fleet. This list is subject to change and CARB will include additional certified test devices when vendors complete the certification process and are issued an EO for their device.




### **CTC Credentialed Testers**

- Only credentialed testers can submit compliance tests
- For-hire credentialed testers are listed on the CARB website
- Anyone can become a credentialed tester by completing the <u>no-cost</u> training course and exam
- Credentialed testers must also create a tester account in CTC-VIS
- No certification required for telematics service using CARBverified OBD device

- Your compliance certificate will be available for you after your payment has been processed.
  - 1-2 business days for Credit and Debit card payments
  - Up to 7 business days for eChecks.
